1. INTRODUCTION

The Phoenix Out of Hours Emergency Stock Supply Service allows Humber Teaching Foundation NHS Trust (HTFT) to obtain emergency stock from the York Phoenix depot when it cannot be obtained by any other routes.

It is a 24/7 service for use outside of the Pharmacy departments usual operating hours (Monday – Friday 0900 – 1730, excluding bank holidays)

2. SCOPE

This applies to employees of HTFT, contract and Agency staff working on an in-patient unit.

3. DUTIES AND RESPONSIBILITIES

Nurse in charge or Clinician – to place the order and ensure that this service is only used for its intended purpose when the stock cannot be obtained by any other routes.

4. PROCESS

- 1. This service should only be used when the stock cannot be obtained by any other routes. Follow the flow chart [appendix 2] to rule out all other options.
- 2. Clinician to contact the York Phoenix depot by calling 08447369981 and request the product required.

The clinician will be required to provide the following information on the call:

- Account number (See appendix 1)
- Product details including: Name (if brand required please state brand name), form, strength and pack Size.
- Quantity in original packs it must be clear as to quantity required. Phoenix operate in packs; not units/tablets, so if 56 tablets are required, 2 boxes of 28 or 1 box of 56 must be requested accordingly.
- 3. When the need to use this service has arisen, an email should be sent to hnf-
 tr.pharmacyprocurement@nhs.net stating the product required and the outcome of the call.
